DESCRIPTION : To meet Corps of Engineers' Rehabilitation and Inspection Program requirements and Federal Emergency Management Agency requirements for the issuance of a Letter of Map Revision, all vegetation within 15' of the face of the wall or toe of the levee will be removed with clearing to the edge of the river in isolated locations. These areas will be protected with erosion control blankets anchored in trenches in the riverbank. Any roots greater than 1/2" will be removed and depressions from the removal of tree root wads will be filled as needed. The final activity will be permanent seeding and mulching, placing erosion control matting, or placing sod. Details of the project are contained in information and plans received at the Division of Water on August 29, 2014, September 8, 2014, September 12, 2014, September 29, 2014, October 1, 2014, October 7, 2014, November 13, 2014, December 16, 2014, December 29, 2014, January 28, 2015, February 2, 2015, February 3, 2015, February 4, 2015, February 24, 2015, March 26, 2015, April 1, 2015, April 13, 2015, April 20, 2015 and May 18, 2015.

PERMIT VALIDITY : This permit is valid for 24 months from the "Approved On" date shown on the first page. If construction work in the floodway has not been completed by June 11, 2017 the permit will become void. This permit may be renewed one (1) time for a period not to exceed two (2) additional years only if a written request for the two (2) year permit renewal is received by DNR, Division of Water prior to June 11, 2017. Thereafter the permit will become void and a new permit will be required in order to continue work on the project.

This permit becomes effective 18 days after the "MAILED" date shown on the first page. If both a petition for review and a petition for a stay of effectiveness are filed before this permit becomes effective, any part of the permit that is within the scope of the petition for stay is stayed for an additional 15 days.

CONFORMANCE : Other than those measures necessary to satisfy the "General Conditions" and "Special Conditions", the project must conform to the information received by the Department of Natural Resources on: August 29, 2014, September 8, 2014, September 12, 2014, September 29, 2014, October 1, 2014, October 7, 2014, November 13, 2014, December 16, 2014, December 29, 2014, January 28, 2015, February 2, 2015, February 3, 2015, February 4, 2015, February 24, 2015, March 26, 2015, April 1, 2015, April 13, 2015, April 20, 2015 and May 18, 2015. Any deviation from the information must receive the prior written approval of the Department.

Number	Special Condition
(1)	revegetate all bare and disturbed areas with a mixture of grasses (excluding all varieties of tall fescue) and legumes as soon as possible upon completion; low endophyte tall fescue may be used in the ditch bottom and side slopes only
(2)	do not work in the waterway from April 1 through June 30 without the prior written approval of the Division of Fish and Wildlife
(3)	do not cut any trees suitable for Indiana bat roosting (greater than 3 inches dbh, living or dead, with loose hanging bark) from April 1 through September 30
(4)	appropriately designed measures for controlling erosion and sediment must be implemented to prevent sediment from entering the stream or leaving the construction site; maintain these measures until construction is complete and all disturbed areas are stabilized
(5)	seed and protect all disturbed streambanks and slopes that are 3:1 or steeper with erosion control blankets (follow manufacturer's recommendations for selection and installation); seed and apply mulch on all other disturbed areas
(6)	implement the mitigation plans (found within the U.S. Army Corps of Engineers' response to the October 31, 2014, Incomplete Application Notice), dated March 31, 2015, which were received by the Division of Water on April 1, 2015, by the end of spring 2016

- (7) an annual report must be submitted to the Central Region Environmental Biologist (Division of Water, 402 W. Washington St., RM W264, Indianapolis, IN 46204-2641) by December 31 of each year to track the initiation, progress, and success of the mitigation sites;
- reports must be submitted each year following issuance of an approved permit, even if work has not been initiated on the mitigation sites;
 - an annual report may simply state that work on the mitigation sites has not been initiated;
 - beginning the first complete growing season after all plant materials have been installed, the mitigation sites must be monitored for the survival of the plantings for a minimum of three years;
 - monitoring may occur at any point during the growing season with approximately 12 months between each monitoring event;
 - the mitigation sites must have a minimum survival rate of 75% of planted material in each woody layer (woody canopy, woody understory) and 80% mean vegetative cover of native perennial species in the herbaceous layer during each monitoring event for three consecutive years to be considered successful;
 - if a minimum survival rate of 75% of woody plantings and 80% cover of native herbaceous species is not achieved within the monitoring period, corrective replanting of the appropriate plant type must be conducted prior to the next monitoring event to meet the minimum survival rate;
 - annual reports must include a narrative of the mitigation sites progress, the location and number of acres planted, a list of species planted on site for each layer, the number of stems planted for both woody canopy and understory layers and the seeding or planting rate for the herbaceous layer, the estimated survival rate of planted material for each layer, a minimum of 10 photographs of planted materials and mitigation site conditions, and corrective replanting measures to be implemented if the minimum survival rate has not been achieved
- (8) place a restrictive covenant (developed in coordination with a DNR biologist) on the mitigation sites within 60 days of project initiation to protect the mitigation sites from any future disturbance; a copy of the covenants must be provided to the Central Region Environmental Biologist by mailing it to the Division of Water, 402 W. Washington St, Room W264, Indianapolis, IN 46204-2641
- (9) except for the material used to fill in any depressions left as a result of the removal of roots, place all excavated material landward of the floodway *
- (10) do not leave felled trees, brush, or other debris in the floodway *
- (11) obtain the prior written approval of the Department for any additional construction, excavation or filling in or on the floodway * beyond the scope of the project
- (12) * NOTE: for regulatory purposes, the floodway is defined as that shown on Panel 135 of the Marion County Flood Insurance Study dated January 5, 2001
