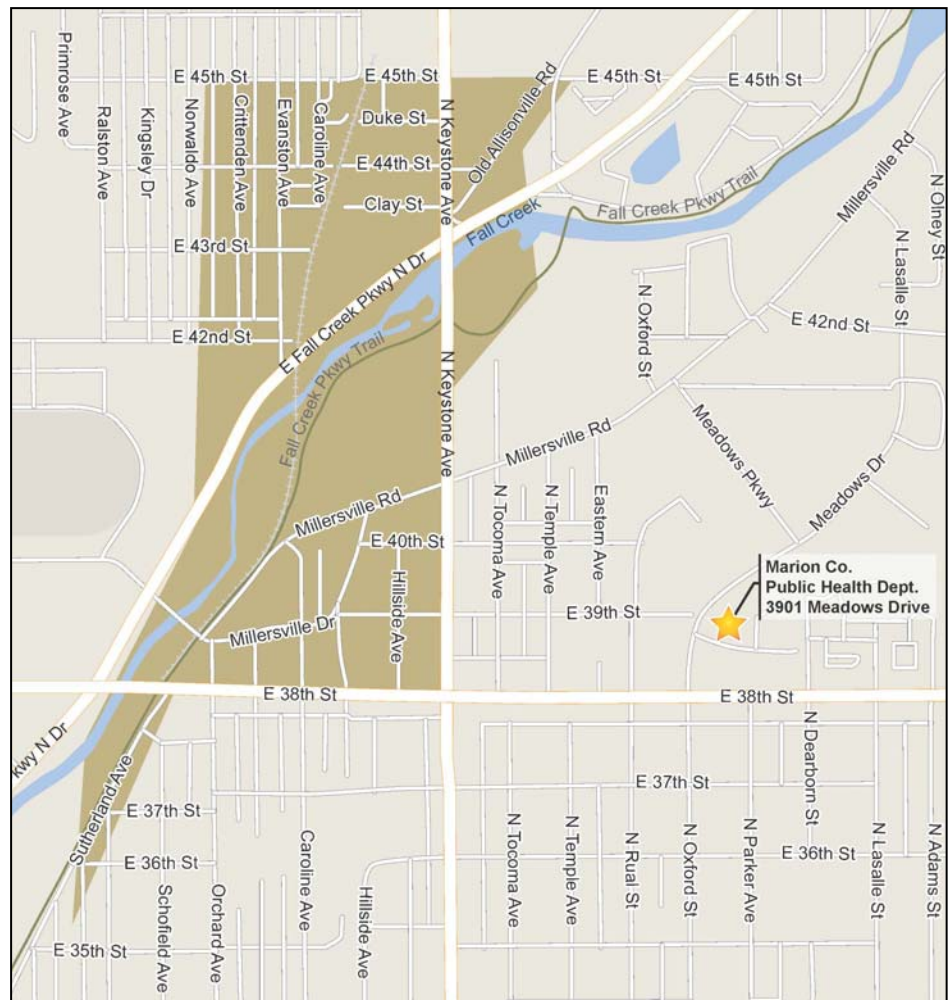

The U.S. Environmental Protection Agency plans to meet with Indianapolis residents to learn about their concerns and what information they need about the Keystone Corridor Superfund site.

The site consists of the Fall Creek well field and potential sources of the groundwater contamination. The groundwater has been affected by chemicals typically used by a variety of industries such as dry cleaners and metalwork shops. These chemicals include volatile organic compounds such as tetrachloroethene, or PCE; trichloroethylene, or TCE; cis-1,2-dichloroethene, or cis-1,2-DCE; and vinyl chloride. All are known to be harmful to people.

Interviews will take place at the Marion County Public Health Department, 3901 Meadows Drive, and will take about 30 minutes each. EPA will use information from these interviews to write the Community Involvement Plan for the site.
